Minerva finishes implementation in Hungary

Minerva today announced the completion of the ERP QAD implementation in Szórádi és Társai Kft, a Hungarian company that is part of the Czech Radka group.

Radka, a distributor of chemical and technological products for the construction industry, coatings, water treatment products, plastics, rubber products and enamel technology made by the world's leading manufacturers, has been Minerva's customer for three years. After the implementation of ERP QAD at the Radka headquarters in Pardubice, the company continued with the implementation in its subsidiaries in Poland and Ukraine. Minerva is currently implementing ERP QAD in Romania and Serbia.

The current project in the Hungarian plant of Radka was focused on the Distribution and Finance modules. Interesting aspects of the project implemented by Minerva included resolving data exports and imports or central numbering of SKUs and suppliers. The project involved, among others, the replication and validation of data from a controlling database that contains inventory levels, sales and balance of payables and receivables. Minerva set up in QAD a link between the prices from purchase orders and specific stock batches as well as between each sales order and the invoice that the batch corresponds to. Last but not least, sales analysis was also implemented. Customized setup of QAD enables allocating ancillary acquisition costs to receipts by volume or price. This function was extended with the option to also allocate transport costs to issued invoices and include in the analyses also indirect costs of transport to customers and other types of costs associated with the individual items.

ERP QAD including additional applications runs on a virtual server. In all foreign branches, processes were rolled out from the Czech headquarters with regard to the specific laws of the given country. Radka plans to work with Minerva on implementing support of automated data collection and warehouse management using barcodes.

"I see the greatest benefit of the new ERP QAD system in having the data available almost fully online. The data is accurate, eliminating the error rate and delays caused by fixing errors. We appreciate the consolidation of processes that helped us standardise our business processes at all plants, including those abroad. We are now working on setting up a reporting system that will create reports in a single currency and on a single timeline," says the Radka CFO Eva Šmídová, adding: "Minerva's consultants were always there to help us resolve our specific issues."
